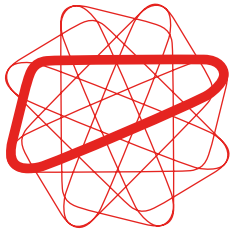

Metropolitan areas consist of functionally connected heterogeneous environments that cross administrative boundaries and different spheres of competence. On the one hand, the great challenge is to sharpen a common identity of the metropolitan region. On the other hand, cross-border cooperation needs to be established within a well programmed polycentric network, shaped by the potential and role of all places. Multi-level governance structures as well as inter-municipal cooperation mechanisms are necessary in order to establish intra-regional synergies, ensure a coherent approach and thus, meet the challenges of sustainable metropolitan development. By exchanging knowledge and experience between different metropolitan areas, we will discuss how to improve the attractiveness, competitiveness and integration of the Vienna Metropolis.

Metropolregionen bestehen aus funktional zusammenhängenden heterogenen Räumen, die administrative Grenzen und unterschiedliche Zuständigkeiten überschreiten. Die große Herausforderung besteht darin, eine gemeinsame Identität der Metropolregion zu definieren. Grenzüberschreitende Kooperationen bilden ein polyzentrisches Netzwerk, das durch das Potenzial und die Rolle der einzelnen Orte geprägt ist. Neue Multi-Level-Governance Strukturen sind notwendig, um intra-regionale Synergien zu schaffen und damit eine nachhaltige räumliche Entwicklung zu fördern. Anhand des Inputs verschiedener Metropolregionen diskutieren wir, wie die Attraktivität, Wettbewerbsfähigkeit und Integration der Metropolregion Wien verbessert werden kann.

Form & Function. Metropolitan Development Against the Grain

*Paul Gerretsen, Director of Deltametropolis
Association, Rotterdam*

To talk of metropolitan areas in The Netherlands is both preposterous and dead serious. Lacking a culture of congestion by absence of a relevant gravitational center and a condition of territorial and cultural flatness, cities in The Netherlands are small and cooperation is based on equality. However, piggybacked on centuries of trading opportunities in the delta area, an urban system of highly connected settlements gave form to an almost 50 million inhabitant mega-city-region. To cope with spatial and societal challenges in the flood prone land is therefore a continuous quest for the right scale-level and governance model.



"Avinguda del Vallès" - A Co-Creation Process

The Metropolitan Area of Barcelona is currently drafting the Urban Master Plan, which proposes, among other things, structuring the territory through a network of metropolitan avenues. With our project, we are rethinking a section of one of such avenues, which passes through 4 municipalities and affects multiple public administrations and different levels of governance. Therefore, the challenge is to achieve a shared vision between all the stakeholders. To do so, we are carrying out a co-creation process with an integrated and multi-scalar approach, to respond to the needs of citizens, entities and politicians.



Metropolitan Governance in France. Solving Problems and Creating New Ones

The major French cities have succeeded in creating metropolitan governance arrangements that have few equivalents in Europe in terms of budget, skills and capacity for action. However, these French metropolises are giants with feet of clay. Their capacity to implement ambitious policies is highly dependent on the will of the municipalities, and as soon as they are set up, they are confronted with numerous criticisms. So can metropolitan governance "à la française" be a model for other countries?



Governance Models and Development Ideas for Metropolitan Areas

*Iván Tosics, Urban Sociologist, Metropol-
itan Research Institute, Budapest*

The complex web of urban challenges can only be handled by policies which are integrated from the vertical, horizontal, transversal and territorial aspects. The inevitable externalities of such policies can best be addressed on the territorial level of the functional metropolitan regions. The presentation will expound the results of international research programmes on EU metropolises led by the Metropolitan Research Institute, as well as the main outcomes of two ESPON projects in which Vienna was involved as a case study. The results will reveal options for the governance of functionally connected environments.



Cross-Border Spatial Development. Planning Strategies between Maas and Rhine

*Christa Reicher, Chair of Urban Planning
and Design at RWTH Aachen University*

The tri-national agglomeration between the Meuse and the Rhine is a unique area in many respects. Its location makes it one of the most important cross-border regions in Europe and forms a central, international region where knowledge, technology and services come together. In concretizing a new standard supported by policy, it is necessary to create space for new initiatives and experiments both in terms of working methods (process) and project level (product). The L'EAU (Lab for European Augmented Urbanism) project is developing an integrated spatial strategy based on an analysis of geographic, social and cultural layers. This offers connecting points for further cross-border concepts and projects.

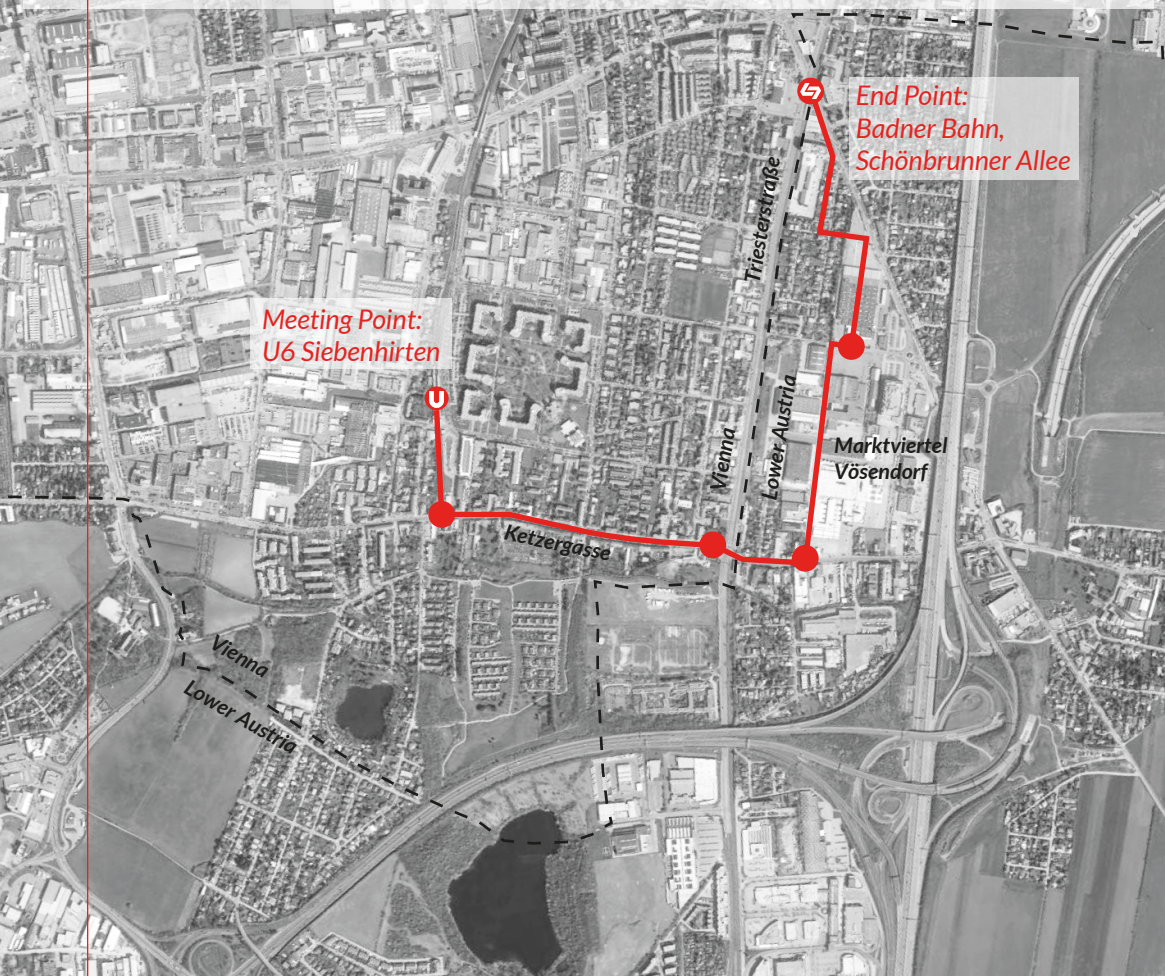

Ein Ort, der Gold wert ist...

Zwischen Simmering und Favoriten

The documentary draws a portrait of Simmering, a district in the southeast of the city of Vienna. Once a typical Viennese working-class district, the proportion of industry and commerce has been steadily declining here since the 1990s and is being replaced by monofunctional residential construction - increasingly in the luxury segment - and space-intensive retail. "A natural development - we live in a post-industrial era" is the narrative that has so far been scarcely questioned. At the same time, the remaining companies complain in unison about a lack of space and unrealizable expansion requests. Young entrepreneurs often look in vain for affordable production locations in the city. And businesses that have been at the same location for centuries are confronted for the first time with complaints from neighbors about noise or smells. What does that mean for a city like Vienna and for Simmering as a former workers' district? Who profits from the marginalization of work and the associated narrative? The film concludes that the rapidly rising property prices in Vienna and speculation are fueling this development and calls into question the concept of land ownership.
